- 1. PURPOSE. To summarize subject OPLAN.
- 2. KEY POINTS
 - Provides sealift evacuation plan from RVN for up to 6,000 evacuees.
 - -- Points out this option is considered undesriable because:
 - --- Concentration of evacuees on MSC shipping moving through inland waterways does not appear prudent.
 - --- Moving of evacuees across Saigon to Newport may be very difficult.
 - -- If the Plan is executed, one BLT will secure Newport (in Saigon) with remainder of a MAB available to reinforce if required.

Subj: USSAG/7AF OPLAN 5060V-2-75 (TALON VISE) (U)

1. Purpose. To summarize USSAG/7AF OPLAN 5060V-2-75 (Option IV, Helicopter Evacuation).

2. Key Points.

- Provides for helicopter evacuation of US noncombatants and designated aliens from Saigon and vicinity. May include fixed wing and sealift to further evacuate from staging area in Vung Tau.

- Assumptions:

-- In-theater forces have been deployed to forward operating locations.

-- EAGLE PULL operations are complete.

-- Tan Son Nhut Airfield is denied to fixed-wing aircraft, and LZ's vicinity Saigon must be used.

-- RVNAF and/or other hostile groups may interfere with evacuation in vicinity Saigon.

-- No mainbody NVA or major VC confrontation is imminent.

-- Operations will be concluded before crowd/small armed group control capability of GSF is exceeded.

-- Friendly governments will provide safe havens for evacuees.

- Force composition:

-- One Marine amphibious brigade (MAB).

-- Two ARG'S

-- One CVA configured for helicopter operations.

-- Two Midway class CVA's (one may be configured for emergency operations of USAF helicopters).

-- USAF helicopter and TACAIR assets (from Thailand).

- Time to commence effective operations from condition of normal readiness (L-hour is launch time of first evacuation aircraft):

-- Minimum of 20 130s and 15 141s can evacuate 10,000 persons plus the 440 Marine GSF in 9 hours and 10 minutes after first plane touches down at Tan Son Nhut. Aircraft will be landed primarily from Kadena, Clark, and Utapao; evacuees transported directly to Bangkok and Utapao.

- 1. PURPOSE. To summarize CINCPAC CONPLAN 5060V.
- 2. KEY POINTS
 - Provides CINCPAC concept of operations for evacuation operations from RVN.
 - -- Conceptualizes evacuation operations occurring under one of three scenarios:
 - --- Scenario A: Simultaneous execution of Options II (airlift) and III (sealift). Requires two USMC BLTs to provide security.
 - --- Scenario B: Simultaneous execution of Options III (sealift) and IV (helicopter). Requires deployment of two USMC BLTs to provide security.
 - --- Scenario C: Simultaneous execution of Options II (airlift) and IV (helicopter). Requires deployment of three USMC BLTs to provide security.
 - -- CINCPACFLT is tasked to provide a MAB afloat to support evacuation operations and three additional BLTs as required (with BLT 1/3 on Okinawa, four BLTs are available (three on Okinawa, one on Subic Bay).

> and participated in EAGLE PULL operations on 12 April. The use of USS HANCOCK as a helicopter platform resulted from non-availability of an LPH and was a landmark occurrence and further demonstrated the versatility of the Navy-Marine Corps team.

- -- BLT 1/9 on 5 April moved from Okinawa to Subic Bay by USAF Cl4ls and embarked on amphibious shipping within four days.
- -- BLT 3/9 was moved from Japan to Okinawa by Marine Corps KCl30s at a time (early April) when amphibious ships were fully committed to EAGLE PULL/ FREQUENT WIND contingencies.

Marine security detachments were rapidly formed and placed on MSC 'ships (50 Marines per ship) to render humanitarian assistance to Vietnamese refugees and to provide ship security. 1st Battalion, 4th Marines was initially tasked to perform this mission and carried out their duties from 4 to 11 April with professionalism. Especially noteworthy was the display of sympathy for the Vietnamese by the Marines assigned this arduous duty. Due to the rapidly changing situation and the strong possibility of the requirement for the battalion to be utilized as part of a ground security force, 1/4 was relieved of evacuation control and assistance duties and immediately reconstituted as a BLT and remains at Subic Bay. On 17 April, III MAF units on Okinawa organized security detachments from combat service and service support elements to replace the 1/4 detachments. Those units were flown from Okinawa to ships off Vietnam on 18-19 April via Subic Bay where they now perform evacuation_control and security duties as required.
- -- On 4 April 1st Battalion, 9th Marines located on Okinawa was given a warning order for movement to Subic Bay. The move was completed within 24 hours. The battalion embarked in amphibious ships at Subic as part of 33rd MAU on 6 April and on 9 April the battlaion sailed for Vietnam to support evacuation operations.





1. By reference (a), Colonel KOETHE stated that the Chief of Staff's Office had requested that Operations be kept informed of the status of Marine Corps security personnel in South Vietnam. The consulate at Bien Hoa has been closed and Marine personnel had been reassigned to the Embassy in Saigon as of yesterday. The consulate at Can Tho was estimated to be closed within 48 hours and personnel reassigned to Embassy Saigon. Therefore, at present, or in the immediate future there will be 75 Marines assigned to the Embassy in Saigon. Approximately one-half will be used for embassy security and approximately one-half at Tan Son Nhut Airport to assist with evacuation.

2. It is reported that the situation was calm, both at the Embassy and Tan Son Nhut Airport.

3. Detailed planning, including evacuation assignments have been completed by the Embassy Marines and personal effects and nonessential equipment have been crated for shipment to the United States. Only essential equipment such as flak jackets, helmets, blues, and utilities are being maintained.

4. Colonel KOETHE was requested to call the Marine Corps Command Center with any updating information, day or night.
